RESPONSIBILITIES OF RENTERS

RENTER'S TIME STARTS WHEN THEY UNLOCK THE GATE AND ENDS WHEN THEY LOCK THE GATE BACK. (THIS INCLUDES ALL DECORATING TIME PRIOR TO RENTER'S EVENT)

NO ALCOHOLIC BEVERAGES ALLOWED ON GROUNDS

DO NOT PUT ANYTHING ON WALLS OR FLOORS, INCLUDING TAPE, PINS, OR NAILS.

IF FLOORS, CEILING, OR WALLS ARE DAMAGED IN ANY WAY, IT WILL BE RENTER'S RESPONSIBILITY TO FIX OR PAY FOR DAMAGES. DO NOT TAPE OR HANG ANTHING FROM THE CEILINGS.

- 1. PLEASE CLEAN BATHROOMS AND KITCHEN AREA.**
- 2. EMPTY ALL TRASH CANS AND DISPOSE OF TRASH. DUMPSTERS ARE LOCATED AT THE SIDE OF THE SALLY WELLS AND RAY GOAD BLDGS.**
- 3. PLEASE SWEEP AND WET MOP ALL FLOORS.**
- 4. TURN OFF AIR CONDITIONER IN SUMMER MONTHS.**
- 5. IN WINTER MONTHS LEAVE HEAT ON 60 DEGREES, LEAVE KITCHEN AND BATHROOM DOORS OPEN.**
- 6. STORE ALL TABLES AND CHAIRS IN THEIR PROPER PLACE.**
- 7. TURN OFF ALL LIGHTS INSIDE AND OUTSIDE.**
- 8. LOCK ALL DOORS AND GATES WHEN YOU LEAVE.**

NO SKATEBOARDS ALLOWED IN OR AROUND THE BUILDINGS.

NO BALLS ALLOWED INSIDE THE BUILDINGS.

MUSIC SHOULD BE KEPT LOW AT ALL TIMES. IF POLICE HAS TO COME TO FAIRGROUNDS FOR ANY REASON, RENTER WILL BE ASKED TO LEAVE GROUNDS AT ONCE. RENT MONEY WILL NOT BE REFUNDED.

PLEASE RESPECT THE HOME OWNERS IN THE NEIGHBORING SUBDIVIONS. THEY HAVE THE RIGHT TO REPORT ANY AND ALL DISTURBANCES THAT MAY OCCUR.

DO NOT DRIVE ON GRASS AROUND THE SALLY WELLS BUILDINGS; DO NOT PULL TO BACK DOOR TO LOAD/UNLOAD.

ANY DAMAGE TO THE BUILDINGS OR THE FAIRGROUNDS WILL BE THE RESPONSIBILITY OF THE RENTER TO FIX, AND SHOULD BE REPORTED AT ONCE.

IF BUILDINGS ARE NOT CLEANED PROPERLY AND THE FAIR BOARD HAS TO GET SOMEONE TO CLEAN THEM, THE RENTER WILL BE RESPONSIBLE FOR THE BILL AND WILL NOT BE ALLOWED TO RENT BUILDINGS AGAIN.

ALL RENTERS WILL LEAVE THE FAIRGROUNDS BY MIDNIGHT (12:00). EVERYONE MUST BE OUT BY 12 MIDNIGHT; EVEN IF RENTER HAS RENTED BUILDINGS FOR MORE THAN ONE DAY. NO ONE IS ALLOWED TO STAY ALL NIGHT ON FAIRGROUNDS PROPERTY.

BUILDINGS THAT ARE NOT CLEANED BY THE ABOVE RULES, WILL HAVE A \$200 CLEANING CHARGE ON TOP OF THE AGREED PRICE FOR RENT.

RENTER WILL NOT HOLD MACON COUNTY AND/OR THE MACON COUNTY FAIR BOARD FOR ANY LOST, DAMAGED PERSONAL PROPERTY OR ACCIDENTS RESULTING FROM ANY EVENT HELD ON FAIRGROUNDS PROPERTY.
