Macon County Fair Board and EXHIBITOR agree as follows:

1. Exhibits are open to any business / commercial or educational group upon space availability.  
(Only one entry per exhibit unless permission by fair board in advance.)
2. Entry fee per exhibitors.  
**SALLY WELLS BUILDING..... 10 X 10 foot - \$100.00**  
**RAY GOAD BUILDING..... 10 X 10 foot - \$ 50.00**  
**BOOTH BARN..... approx..10 X 10 foot - \$ 50.00**
3. Tables may be rented from the Sally Wells Building while supplies last.  
Table rental fee per table.....\$5.00 each (tables CAN NOT be removed from the building)
4. Each Exhibitor is required to give away one door prize of \$25.00 value minimum. Door prizes will be announced on our Website and Facebook page along with the local papers. Each Exhibitor will be responsible for delivering to winners.

5. Exhibits set-up time will be **Friday August 1, from 10-3 and Monday August 4, 10-4. All Exhibits must be ready to show by 4:00. Doors open at 5:00.**
6. **No Food or Drinks shall be given away or sold in the buildings.**
7. **YOU ARE NOT ALLOWED TO TAPE ANYTHING TO THE FLOOR OR TAPE, PIN, OR STICK ANYTHING TO THE WALL.**
8. **Each exhibitor is responsible for their own exhibit during opening hours and must keep the exhibit area clean and presentable.**
9. Exhibit can be picked up Sunday August 10, from 3-5 or Monday 9-12 noon.
10. Judging will be from 4 to 5 on Monday August 4, 2014. One person from each Booth will judge Best Overall Booth in each building and winners will be announced on Wednesday August 6, 2014. All votes must be turned in at the North Central Security Booth in the Sally Wells Building by 8:00 pm. ONLY JUDGE YOUR BUILDING!!
11. Prizes for Sally Wells Exhibitors - Best Overall Exhibit –Prize will be a plaque, ribbon and \$100.00.  
2<sup>nd</sup> Place – Second Place Ribbon and \$50.00.  
3<sup>rd</sup> Place – Third Place Ribbon and \$25.00
12. Prizes for Ray Goad Exhibitors - Best Overall Exhibit –Prize will be a plaque, ribbon and \$50.00.  
2<sup>nd</sup> Place – Second Place Ribbon and \$25.00.  
3<sup>rd</sup> Place – Third Place Ribbon and \$15.00
13. Each Exhibitor will receive up to 4 lanyards with a sleeve pass and will be responsible for these and MUST have to enter into the fair. Exhibitors will be responsible for returning each of these at the end of the fair. (return to any Fair Board Member)
